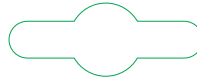

INDICATIONS

Worm remedy against ascarids, hookworms, whipworms and tapeworms in dogs.

COMPOSITION

Each tablet contains:

Praziquantel 50 mg, Pyrantel pamoate 144 mg, Febantel 150 mg

WARNINGS

DO NOT USE SIMULTANEOUSLY WITH PIPERAZINE COMPOUNDS.

DIRECTIONS FOR USE

USE ONLY AS DIRECTED (see table).

Always keep contents with original packaging. Can be administered directly, or mixed with meat, or crushed and mixed with feed. Feeding and fasting before treatment is not necessary.

DOSAGE

Dose according to body mass, ie. 1 Tablet/10 kg e.g.

- Puppies should be dewormed every two weeks, from the age of 2 – 12 weeks, and at regular intervals of 3 – 6 months thereafter to control worm infestation.
- Can be given safely to all dogs including old animals, young pups, working dogs, greyhounds and even to pregnant bitches 10 days before whelping.
